KEYNOTE SPEAKER KAY SPRINKEL GRACE

Kay Sprinkel Grace understands the challenges of 21st century philanthropy as well as its opportunities, and brings her experience from working with countless nonprofit organizations to bear on the current issues affecting donor development, fund raising, outreach, message strategy and volunteerism.

As principal of her own organization since 1989, her clients include public media, hospitals, universities, arts and cultural organizations, environment and social justice organizations, churches and education, as well as community-based services. From 2004 – 2007 she was principal lead consultant to the Corporation for Public Broadcasting for a major giving initiative in which more than 100 public television licensees participated. A goal of her consulting is to mentor and strengthen leaders within organizations to grow their success while achieving their immediate goals.

She is a frequent speaker at Association of Fundraising Professional (AFP) local and regional meetings, including AFP Vineyards and Golden Gate, as well as AFP International in 2014. She has participated internationally as a keynote speaker and workshop leader in conferences in Australia, The Netherlands, Slovakia, Czech Republic, Republic of Georgia, Sweden, Great Britain, France and Russia. In 2013 she returned to the International Fundraising Festival in Prague, and was a workshop speaker at the International Fundraising Congress in The Netherlands and a keynote speaker at the Blackbaud Conference in Sydney, Australia, both in October, 2013. Her BA and MA are from Stanford University, where she is a recipient of their highest award for volunteer service, The Gold Spike, as well as their Centennial Medal, Outstanding Achievement Award, Award of Merit and Associates Award. The Golden Gate Chapter of AFP awarded her their Outstanding Professional Fundraiser Award (now the Henry A. Rosso Award) and their President's Award.

She is the author of six books related to philanthropic practices and board engagement: Beyond Fund Raising (1997 and 2005, Wiley); High Impact Philanthropy (2001, co-author Alan Wendroff, Wiley); Over Goal! (2005, Emerson & Church); The Ultimate Board Member's Book, (Third Edition, Revised 2013, Emerson & Church); Fund Raising Mistakes That Bedevil All Boards (Revised 2009, Emerson & Church) and The AAA Way to Fundraising Success: Maximizing Involvement, Maximizing Results, (2009, Whit Press of Seattle and Jackson Hole).

Her articles have appeared in *Advancing Philanthropy*, the publication of the Association of Fundraising Professionals (AFP), and she was a regular contributor for more than 10 years to *Contributions*, a publication of Emerson & Church, Medfield, MA. She has provided national and regional webinars for organizations including The Piper Trust, Arizona; California Council of Land Trusts; Bank of America; Asking Matters; the Corporation for Public Broadcasting and Hubb (Canada).

As a volunteer, she serves on the Advisory Board of the Czech Fundraising Institute, Prague, Czech Republic, and the governing board of Philharmonia Baroque Orchestra, San Francisco.

She lives and works in San Francisco and is passionate about her family, philanthropy, writing, travel and her photography.

Together with her husband, Fritz, the Grupes have focused their charitable energies on public education, literacy, and community development to improve the lives of everyone who calls San Joaquin County home.



ANNETTE MURDACA

Another native Californian, Annette Murdaca is a third generation member of the Vaccarezza Family of Lodi. With a solid background of success in two family businesses, Annette and her husband, Jim, established the Vaccarezza-Murdaca Family Foundation in 1998 and helped build the Lodi House (women's shelter). She remains the founding mother of Festa della Donna, an annual fund raising event for Lodi House. The Murdacas have also supported the Women's Shelter at Salvation Army Hope Harbor and work tirelessly to provide food, shelter, and educational opportunities to those in need so that "all God's children can find comfort and care."

Born in Tracy, Tony Souza and his wife, Gloria, have been and remain community and philanthropic leaders. Like the Grupes and Vaccarezza-Murdacas, a complete list of their accomplishments and contributions could fill volumes. Today, they continue their legacy of giving through the Souza Family Foundation and work to bestow the values taught to them by their parents to their children and grandchildren.

Outstanding Philanthropist



The Ottesens are true unsung heroes preferring to quietly give while inspiring others to donate millions of dollars to charitable organizations. Their giving in San Joaquin County has included the University of the Pacific, Haggin Museum, Community Blind Center, Ducks Unlimited, Stockton Chorale and Zion Chamber Orchestra. Peter's weekly articles in The Record champions conservation and excursions that take children and families outdoors to relish in the bounty of nature. He designed the San Joaquin County Outdoor School, an education program that had been in place for more than 35 years. Lexie is a Director for the Community Center for the Blind and a Haggin Museum Art and History Docent.



JOSEPH BERNARDICOU

Outstanding Youth in Philanthropy

Joseph "Joey" Bernardicou is a Youth Minister for the Cathedral of The Annunciation in Stockton, Western Region Youth Spokesman for American Heart Association and the Founder and Chairman of the Joseph Bernadicou Golf Tournament. Proceeds from the tournament have been donated to the American Heart Association and area hospitals for research and development of treatment for heart conditions like the one he has lived with for several years. As a member of Annunciation Parish, he socializes and interacts with the youth of the Stockton community and is as a positive force in the lives of Stockton children who would otherwise be surrounded by dysfunction, poverty, and violence. Joey volunteers as a designated driver and serves on several St. Mary's High School service clubs. In the opinion of his teachers and church, Joseph embodies the words of St. Francis de Sales, "Be who you are and be that well."
