KEYNOTE SPEAKER

"Raise More Money ... Grow a Better Future"

Jim Eskin's leadership roles span more than 30 years in fundraising, public affairs and communications in the San Antonio area. Fundraising benchmarks include establishing records for gifts from individuals at The University of Texas at San Antonio (UTSA), Our Lady of the Lake University (OLLU) and Alamo Colleges Foundation. In 2009, he began current responsibilities as Executive Director of the Alamo Colleges Foundation, the philanthropic arm of the community college system with an enrollment of more than 60,000 credit students per semester, more than all the other colleges and universities in Bexar County combined. Since then, foundation assets and scholarship dollars awarded have tripled. He has authored more than 100 guest columns that have appeared in daily newspapers and business journals across the country. He publishes Stratagems, a monthly e-newsletter exploring timely issues and trends in philanthropy, advocacy, and image. He also enjoys training board members and staff on fundraising principles and best practices.

Tim Daly spent 35 years in television news as a reporter and anchor. 24 of those years were spent in the Sacramento market working for KXTV as the San Joaquin Valley Bureau Chief. In three short years as chairpersons of the Kentucky Derby West, a premier fundraising event for Hospice of San Joaquin, Laura and Randy invested well over 400 hours of personal time to successfully raise over \$100,000. Individually, Laura served the Lodi Arts Commission, Lamda Theta Phi, Emmanuel Lutheran Church, and Hospice of San Joaquin's Lodi Butterfly Auxiliary. Randy served United Way of

San Joaquin, Lodi Kiwanis Club and the American Heart Association. Laura and Randy enjoy working as a team and together have served Hutchins Street, Children's Dream "PALS" of Lodi, and the United State Pony Club.

ALEX G. AND FAYE SPANOS FAMILY

Outstanding Philanthropist

Alex and Faye Spanos believe in giving back in gratitude for all they have been given. They have imbued that spirit of philanthropy in their family who carry on their tradition of giving generously of themselves to their family, friends, colleagues and community with love and concern. Both native Stocktonians, they have spent their lives building up those around them, both at work and at home. Now their four children – Michael, Dean, Dea and Alexis – carry on that legacy. Dea Spanos Berberian founded the Super Bowl Raffle which has provided more than \$3.5 million to local charities along with serving on several



boards and fund raising committees. Alexis founded the Cool Cats and Barking Dogs, an annual special event benefitting the Stockton Animal Shelter and supports numerous athletic and educational programs and activities. Through their company and from their personal assets, they give generously to so many charitable organizations, it's impossible to count. From the Alex G. Spanos Center and Faye Spanos Concert Hall at the University of the Pacific, to the Spanos Elementary School in Downtown Stockton, the impact of the Spanos Family's generosity is evident throughout the region. In addition to the large, transformational gifts, many Spanos gifts were done on a much smaller scale and very quietly without fanfare or celebration. As daughter Alexis noted on Mr. Spanos' 90th Birthday in 2013, *"His philanthropy is his legacy. He would read the newspaper every day. If someone had their musical instruments stolen, he would replace them. If someone died and the family couldn't afford a funeral, he would pay for it." Dea affirms that sentiment, giving credit to both of her parents. <i>"We had a big example set by our parents... It's just how we were brought up."*
